

## Portfolio and Statement Guidelines

*All applicants to the School of Architecture at UL must submit a portfolio and statement for assessment. This is in order to demonstrate their CREATIVE ABILITY.*

### Portfolio for CAO (School Leavers and Mature) Applicants

#### *(a) Content of Portfolio*

WE WANT TO SEE CREATIVE WORK OF THE HIGHEST QUALITY. Applicants are required to include a range of items using a variety of media in order to demonstrate the scope of their creativity. Applicants can choose from diverse media such as, but not exclusive to: drawing and painting, graphics, printmaking and photography, woodworking and ceramics, sketchbooks and design journals (illustrating the design process followed in a project), textiles and dress or clothes making, sculpture and joinery, computer game design, or any other visual media. You must demonstrate your ability to draw in pencil.

THE CHOICE IS UP TO YOU. In all cases, the work submitted must demonstrate your interest, experience as well as aptitude in creative and graphic areas.

#### *(b) Format of Portfolio*

SUBMIT WORK IN A PROTECTIVE FOLDER. Portfolios shall be no larger than A1 in size. We will neither accept DVDs or CDs of work nor submissions by e-mail or online.

SHOW YOUR WORK CLEARLY. A clear and straightforward presentation of your work will serve you best. The presentation quality of the portfolio is part of the evaluation. Be graphically clear – do not embellish the design of the portfolio!

BE SELECTIVE. Show only your best work. Demonstrate a diversity of work. Portfolios should contain not less than 15 and not more than 20 single-sided pages.

ALL WORK MUST BE PRESENTED TWO-DIMENSIONALLY. We will only accept high quality photographs of sculptures, woodworking projects or other three-dimensional objects.

PORTFOLIOS MAY BE COMPOSED OF REPRODUCED WORK. If your work is to be reproduced, please ensure that the reproductions are of high quality: digital scans or photographs, printed using a high-quality printer, or photographic prints.

INCLUDE SKETCHES. You are encouraged to submit complete, unedited sketchbooks along with your portfolio. You may choose to annotate your sketches relating them to some of your other works or to add written comments to put them in context. Please identify all sketchbooks with your name, address and CAO number.

DO NOT INCLUDE TECHNICAL DRAWINGS unless they relate to a design that you have developed in some way. For example, technical drawings that conclude the Leaving Certificate Design and Communication Graphics project are acceptable as they do demonstrate creative ability.

We would highlight the point in these guidelines that while you may include work from DCG, we also require other pieces of work, such as hand drawings, paintings, collage, photographs, photographs of models, photographs of things you have made, etc. Please take note of the phrase in the guidelines *'Your work should demonstrate personal creativity and inquisitiveness through a range of subjects and a variety of media'*

## Written Statement

Architecture thrives on sensitive responses to all aspects of the environment: *In your locale, what are some of the particular characteristics of that environment, both built and unbuilt?*

Rather than preparing an historical outline or an account of facts, share personal observations and consider your own response to, and understanding of, your surroundings. Please pay particular attention to the guide limit of 500 words.

## Assessment of Portfolio and Statement

Portfolios and statements will be assessed by faculty of the School of Architecture on a *Pass or Fail* basis.

In a portfolio we look for creative sensibility, and your ability to observe and record. We seek to detect a visual awareness that reaches beyond taught coursework or technical drawing. Your work should demonstrate personal creativity and inquisitiveness through a range of subjects and a variety of media. We expect to see a fair command of a number of media – demonstrating good skills in pencil drawing is essential. Include sketchbooks or other suitable material that evidence the sensitivity of your observations. You are expected to be selective and to show your work clearly.

In your statement we look for an original response to the initial question. We value personal and sensitive observations over general information. The statement should be well written, preferably typed and carefully formatted.

## Submission of Portfolio and Statement for CAO (School Leavers and Mature) Applicants

**SUBMISSION DATE** – Submissions are only accepted between **Tuesday 23<sup>rd</sup> April 2019 and Friday 26<sup>th</sup> April 2019** during normal office hours (Monday to Friday 8.30am–1pm and 2pm–4.30pm).

**Friday 26<sup>th</sup> April 2019 is the last day to submit your portfolio and statement.**

All submissions should be clearly labelled with your name, address and CAO number. Portfolio and Statement should be submitted together either by mail or in person to:

**COLLECTION DATE** – Portfolios must be collected between **Wednesday May 1<sup>st</sup> 2019 and Friday May 3<sup>rd</sup> 2019** during normal office hours (8.30am–1pm and 2pm–4.30pm). Please be prepared to provide some form of identification when collecting your portfolio.

**AUTHORISE COLLECTION** – Portfolios collected by someone other than the owner of the portfolio, authorisation and identification are required. Please send a note or e-mail to [Sylvia.Carroll@ul.ie](mailto:Sylvia.Carroll@ul.ie) quoting your name, address and CAO number, as well as the name of the person collecting the portfolio on your behalf.

Please note that the University has no facility to store portfolios and will not keep any portfolios still in its possession after 1<sup>st</sup> September 2019.
